PRODUCTION SPECIFICATIONS

FILM/MECHANICAL REQUIREMENTS

▶ All ads should be submitted on disk in **Apple InDesign CS4** with a hard copy proof. **E-mailed ads (high-res pdfs)** should be accompanied by a faxed proof. A Kodak proof (the equivalent of a matchprint) is required on 4-color ads when precise color matching is required. Photoshop, Illustrator, Quark and most other computer formats accepted but may require a nominal conversion charge. **InDesign document page size on all full page ads should be 8 3/8" x 10 7/8."** All color photos, artwork and PMS colors must be converted to CMYK or be subject to a conversion charge. **All solid black boxes and backgrounds should be a Rich Black (40c30m30y100k).** Scans must be high resolution (300 dpi); photos and artwork should be saved as TIFF files when possible, though EPS files are

also accepted. Include all fonts, font suitcases and font families used in your ad. If you do not supply them, we will substitute a font that matches your proof as closely as possible. **West Suburban Living trims to 8 3/8" x 10 7/8."** **An additional 1/2" buffer is mandatory for all live matter, both ad copy and images, that do not bleed.**

▶ When possible, *West Suburban Living* will provide limited layout and design assistance for a nominal charge. Scans, photostats, screens, halftones and other special design services are subject to additional charges and need to be submitted in advance.
